Good morning everyone,

Attached is a beginning version of the DACA FAQs revised in light of yesterday's announcements. They have been modified slightly, but as the DACA WG, we need to clean them up, and edit as necessary. DHS wants the current FAQs down from and these up on our website by the end of the day. I am working on getting an ECN version of the document, so I'll send you the link as quickly as I can.

Basically we have 80 FAQs – I'll do the first 27, SCOPS can do the next 27, and OCC can take a swipe at the remaining 26 (and if the numbers don't quite make sense as we get into editing, we can discuss throughout the day). Our goal is to use as much information as was posted yesterday in AS1's memo and the accompanying FAQs (I've attached a doc with those), not to make any new policy, reuse as much of the existing FAQs as possible, and drop any FAQs that we reasonably think the public doesn't need any more given that we will not be accepting any new initial requests at this point.

So, as far as a timeline goes, I'd start reading the FAQ Document as soon as you can and start editing as soon as I get the ECN link. We should aim for our first round of pens down at 2 PM and try for a call around there. I've put SCOPS, OCC, OP&S, OCOMM, and Director's Office leadership in the cc line of this email, but going forward, we can drop them until it's time to get clearance. We can also pull in more of the WG as necessary.
