



**We invite you to support a bill which will benefit ALL Coloradans** by making our roads safer, generating more state revenue and stimulating the economy by providing driver's licenses for undocumented Colorado residents. We estimate as many as 150,000 additional Colorado residents would qualify for a state ID or driver's license. This campaign builds on the success of the Initiative 52 ballot campaign, involving 1,200 volunteers across the state and collecting more than 30,000 signatures with less than \$12,000.

**The bill requires Colorado residents to establish their community ties** and identity in order to get a license or ID. Colorado residents who cannot provide proof of legal presence will be required to:

- 1) Show their Individual Tax Identification Number issued by the Internal Revenue Service
- 2) Show a Colorado tax return for last year
- 3) Present one of the following government issued form of ID from their country of origin: passport, birth certificate, military ID, Voter registration card.

**Safer:** Allowing everyone in our state to access a driver's license or state ID helps Colorado identify who lives here, and makes the roads safer by allowing more Colorado residents to take the driver's test and to be covered by car insurance. Finally, each new driver represents a prospective organ and tissue donor, up to 150,000! literally saving lives.

**State Revenue:** All Colorado residents who cannot provide proof of legal presence will be required to show a Colorado tax return in order to get a license. These new drivers will also pay car registration and driver's license test fees. This revenue benefits the state coffers and every Colorado resident. Imagine 150,000 new people registering their car!

**Economy:** Licensed drivers can more easily purchase vehicles and car insurance; the bill could drive new economic activity in two businesses hit hard by the downturn.
