⁵ On June 4, 2008, the U.S. District Court for the District of Oklahoma enjoined the law pending the resolution of litigation. *Chamber of Commerce, et al. v. Edmondson, et al., and Kemp, Jr., et al.,* No. 08-6127, 08-6128 (W.D. Okla., June 4, 2008) (order granting preliminary injunction). Public employers would have had to use the program by Jan. 1, 2007, and public contractors by Jan. 1, 2008. However, the 10th Circuit struck down part of the E-Verify law on Feb. 3, 2010, and the provision that requires public contractors (7(b)) and public employers (7(a)) to use E-Verify is currently in effect. The provision mandating E-Verify for all employers was struck down. See *Chamber of Commerce, et al. v. Edmondson*, 594 F.3d 742 (10th Cir. 2010).

⁶ On Jan. 5, 2011, Rhode Island's Governor Chafee repealed Executive Order 08-01 (enacted on Mar. 27, 2008) that mandated E-Verify for public employers and contractors in the state. There is no mandatory E-Verify law or order currently on the books in Rhode Island.
