NILC'S ECONOMIC JUSTICE PROGRAM FOCUSES ON BATTLING RETALIATION AGAINST AND EXPLOITATION OF LOW-WAGE IMMIGRANT WORKERS, AND INCREASING IMMIGRANTS' ACCESS TO EDUCATION, GOVERNMENT RESOURCES, AND OTHER TOOLS THEY NEED TO HAVE ECONOMIC MOBILITY. CURRENTLY, NILC IS SUPPORTING STATE CAMPAIGNS TO ENSURE THAT INDIVIDUALS IN DEPORTATION PROCEEDINGS WITH LABOR OR CIVIL RIGHTS CLAIMS CAN OBTAIN ADMINISTRATIVE RELIEF UNDER THE ADMINISTRATION'S PROSECUTORIAL DISCRETION POLICY.
