NILC'S ACCESS TO LEGAL STATUS PROGRAM WORKS TO ENSURE THAT LOW-INCOME IMMIGRANTS HAVE FULL ACCESS TO THE VARIOUS FORMS OF IMMIGRATION STATUS EXISTING UNDER CURRENT LAW, AND ADVOCATES FOR IMMIGRATION REFORMS. DURING THE PAST YEAR, NILC HAS BEEN SPEARHEADING NATIONAL IMPLEMENTATION OF THE "DEFERRED ACTION FOR CHILDHOOD ARRIVALS" (DACA) PROGRAM, AND PROVIDING ADVICE AND ASSISTANCE TO STATE AND LOCAL GROUPS WORKING ON DACA.
