1 Plaintiff and Defendants (collectively “Parties”), by and through their counsel of
2 record, hereby submit this Joint Motion of Voluntary Dismissal per the following:

3 WHEREAS on April 18, 2017, Plaintiff Juan Manuel MONTES BOJORQUEZ
4 (hereafter “Mr. Montes”) filed a Freedom of Information Act (“FOIA”) complaint in
5 the instant action against Defendants United States Customs and Border Protection and
6 United States Citizen and Immigration Services;

7 WHEREAS on May 22, 2017, Mr. Montes amended his initial FOIA complaint
8 to add additional causes of action under the Due Process Clause of the U.S. Constitution,
9 the Immigration and Nationality Act, and the Administrative Procedure Act;

10 WHEREAS on July 14, 2017, Mr. Montes filed a motion to file certain
11 documents under seal, and Defendants filed a non-opposition to that motion on August
12 8, 2017;

13 WHEREAS on July 17, 2017, Mr. Montes filed a motion for preliminary
14 injunction seeking his return to the United States;

15 WHEREAS on September 8, 2017, the Court issued an order consolidating the
16 motion for preliminary injunction with a trial on the merits pursuant to Federal Rule of
17 Civil Procedure 65(a)(2);

18 WHEREAS on October 5, 2017, Defendants produced supplemental documents
19 responsive to Mr. Montes’s FOIA requests, resolving all claims regarding the FOIA
20 dispute;

21 WHEREAS, Mr. Montes no longer seeks to pursue the remaining claims present
22 before the Court; and
