

## Afghan New Arrivals and Access to Public Benefits

This document provides a summary of newly arrived Afghans' eligibility for federal public benefits. It specifically covers eligibility based on the immigration statuses named by the [U.S. Office of Refugee Resettlement \(ORR\)](#) as the most common among newly arrived Afghans (additional requirements such as income thresholds may apply).<sup>1</sup>

The information is provided to support local advocates and service providers who want to learn more about the benefits that Afghan new arrivals may be able to receive. The information is focused on federal public benefits programs, but additional options may exist in your state.

Afghan Special Immigrant Visa holders ( <b>SIV</b> ); and	Afghans entering with SIV status or SQ/SI Parole are eligible for the major federal means-tested public benefit programs <u>without</u> a five-year waiting period, as well as other federal public benefits.
Special Immigrant ( <b>SQ/SI</b> ) parole	They are also eligible for refugee cash, refugee medical and refugee resettlement services provided through the Office of Refugee Resettlement (ORR).
Afghans granted other forms of <b>humanitarian parole</b> during a specific period	Afghans granted humanitarian parole between <b>July 31, 2021, and September 30, 2022</b> — and their spouses, children, parents/guardians of unaccompanied children who are granted parole after that date — are eligible for federal means-tested public benefit programs without a waiting period, as well as other federal public benefits, including those provided by ORR. Eligibility for this group continues until March 31, 2023, or the end of their parole term, whichever is later.

### ASSISTING AFGHAN NEW ARRIVALS WITH ACCESS TO SERVICES

On September 30, Congress [passed a law](#) that allows Afghans granted parole between July 31, 2021, and September 30, 2022, to be eligible for federal benefits to the same extent as refugees. (Their spouses, children and parents/guardians of unaccompanied minors granted parole after that date are also eligible for these benefits). On August 3, 2021, ORR issued a [policy letter](#) updating the public on the documentation requirements for Afghans to be eligible for services offered by the Refugee Resettlement Program (RRP). Individuals must have documents showing that they have been issued one of the specific statuses or classifications served by ORR to receive ORR benefits or services.

### QUICK GUIDE TO FEDERAL BENEFITS ELIGIBILITY FOR AFGHAN NEW ARRIVALS
